- a. Authorize and approve the Director of the Emergency Management or designee to submit a grant application to the 2026 State Fire Capacity Grant Program for a total amount not to exceed \$200,000, with a 24-month performance period of October 1, 2026, to September 30, 2028, to fund the development of a Community Wildfire Protection Plan, as well as potential hazardous fuels reduction and maintenance projects on non-federal lands and wildfire prevention and mitigation education and outreach efforts; and
- b. Authorize and approve the Director of Emergency Management or designee to execute all necessary forms and documents for the application to this grant; and
- c. Direct Department of Emergency Management staff to return to the Board of Supervisors for approval prior to acceptance of any grant awards.

RECOMMENDATION:

- a. Authorize and approve the Director of the Emergency Management or designee to submit a grant application to the 2026 State Fire Capacity Grant Program for a total amount not to exceed \$200,000, with a 24-month performance period of October 1, 2026, to September 30, 2028, to fund the development of a Community Wildfire Protection Plan, as well as potential hazardous fuels reduction and maintenance projects on non-federal lands and wildfire prevention and mitigation education and outreach efforts; and
- b. Authorize and approve the Director of Emergency Management or designee to execute all necessary forms and documents for the application to this grant; and
- c. Direct Department of Emergency Management staff to return to the Board of Supervisors for approval prior to acceptance of any grant awards.

SUMMARY:

Department of Emergency Management (DEM) intends to submit an application to the 2026 State Fire Capacity Grant Program for an estimated amount not to exceed \$200,000 with a 24-month performance period of October 1, 2026, to September 30, 2028. Funding for the 2026 State Fire Capacity Grant is provided for California Fire Safe Council (CFSC) from the Cooperative Fire Program of the U.S. Forest Service (USFS), Department of Agriculture, Pacific Southwest Region.

DISCUSSION:

California Fire Safety Council (CFCS) announced funding for the 2026 State Fire Capacity (SCF) Grant Program. The State Fire Capacity Program serves as a mechanism to help California communities respond to the growing concern over catastrophic wildfire and exemplify efforts to create fire-adapted communities through hazardous fuels reduction and maintenance projects on non-federal

lands, Community Wildfire Protection Plans and other wildfire mitigation plans or assessments, as well as wildfire prevention and mitigation education and outreach efforts.

DEM will utilize funds to develop a Community Wildfire Protection Plan (CWPP), as well as potential hazardous fuels reduction and maintenance projects on non-federal lands and wildfire prevention and mitigation education and outreach efforts. The CWPP is an essential tool for wildfire management as it provides a comprehensive assessment of wildfire risk countywide and a coordinated strategy to reduce risk, protect lives and property, and improve community resilience through prioritized mitigation actions, fuel reduction, and emergency planning.

DEM is committed to working together with its partners and the fire prevention community to ensure the County of Monterey has an evidence-based, data-driven, and community-informed CWPP to reduce wildfire risk and enhance overall resilience. This will enhance the Operational Area capacity and lead efforts to unify, implement mitigation strategies, support county-wide wildfire planning, and contribute to statewide data and preparedness initiatives.

OTHER AGENCY INVOLVEMENT/COMMITTEE ACTIONS:

County Counsel, Auditors and Contracts Purchasing review documents in relation to the grant and approve as to form.

FINANCING:

Applying to this grant program will not impact the Department of Emergency Management's FY 2026-27 Adopted budget. DEM will return to Board of Supervisors to request an increase in appropriations upon award approval by the granting agency. This grant requires the awardee to provide a cost share or in-kind 1:1.5 match. DEM will provide an in-kind match from existing non-federal sources. The award amount is estimated not to exceed \$200,000, is reimbursement-based, and includes management and administration costs.
