This Assignment (this "Assignment") by and between ExxonMobil Oil Corporation ("EMOC"), a New York corporation with an address of 5959 Las Colinas Blvd, Irving, Texas 75039, Mobil Pacific Pipeline Company ("MPPC"), a Delaware corporation with an address of 22777 Springwoods Village Parkway, Spring, Texas 77389, ExxonMobil Pipeline Company LLC ("EMPCo"), a Delaware limited liability company with and address of 22777 Springwoods Village Parkway, Spring, Texas 77389 (each, individually, an "Assignor") and Green Gate San Ardo LLC., a Delaware limited liability company, with an address of 1199 Main Avenue, Suite 101, Durango, Colorado 81303 ("Assignee"), is executed on the dates set forth in the respective notary certifications below, but effective for all purposes as of 12:01 a.m. local time in Houston, Texas on January 1, 2022 (the "Effective Date"). Assignor and Assignee are referred to individually as a "Party" or collectively as the "Parties".

RECITALS

WHEREAS, pursuant to that certain Purchase and Sale Agreement by and between Assignor and Assignee, January 1, 2022 (the "PSA"), Assignor desires to sell, and Assignee desires to purchase the Assets that are defined and described as "Assets" therein.

WHEREAS, references herein to terms which are defined separately herein or in the PSA shall have the meaning prescribed to such term herein or in the PSA, as applicable, even if the term (as printed in this Assignment) is printed in ALL CAPITALIZED text, in each case, unless the context expressly requires otherwise. Capitalized terms used herein but not defined herein shall have the meanings assigned to such terms in the PSA.

NOW, THEREFORE, in consideration of the premises and of the mutual promises, representations, warranties, covenants, conditions, and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and Assignee agree as follows:

ASSIGNMENT

Section 1. Assignment. Assignor, for and in consideration of the sum of Ten Dollars (\$10) cash in hand paid and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby GRANTS, BARGAINS, SELLS, CONVEYS, TRANSFERS AND ASSIGNS, and by these presents has GRANTED, BARGAINED, SOLD, CONVEYED, TRANSFERRED AND ASSIGNED unto Assignee all of Assignor's right, title, and interest in and to the assets described in Section 1(a) through 1(o) below (such assets, less and except for the Excluded Assets, as defined below, collectively the "Assets"):

With respect to EMOC:

- (a) the San Ardo Terminal;
- (b) the EMOC Pipelines;
- (c) all platforms, facilities, equipment, machinery, fixtures, pipelines, gathering systems, tanks, tubing, pumps, motors, compression equipment, flow lines, processing and separation facilities, structures, materials and other real, personal and mixed property, operational and nonoperational, known or unknown, located in or on the San Ardo Terminal, the EMOC Pipelines or other Assets and primarily used or held for use in connection with the ownership or operation of the San Ardo Terminal, the EMOC Pipelines or other Assets, including the equipment and materials inventory set forth on Schedule 3.2(b), and including any of the foregoing described on Exhibit A;
- (d) subject to Section 3.2(b) of the PSA, all Hydrocarbons including line fill, attributable to the Assets in pipelines, in tanks or otherwise in storage (including inventory) as of the Effective Time;
- (e) all Rights-of-Way that are used primarily in connection with the ownership or operation of any of the San Ardo Terminal Assets, the EMOC Pipelines or other Assets, including the Rights-of-Way set forth in Exhibit B;
- (f) to the extent that they may be assigned, all Permits that are primarily used in connection with the ownership or operation of the San Ardo Terminal, the EMOC Pipelines or other Assets;

(g) to the extent they may be assigned without the payment of any fee or obligation on the Assignor, the Existing Contracts;

(h) to the extent they may be assigned without the payment of any fee or obligation on the Assignor, the Marketing Contracts set forth on Schedule 2.2(h);

(i) all accounts, trade credits, capital credits, accounts receivable, and all other proceeds, income or revenues attributable to the Assets with respect to any period of time from and after the Effective Time.

With respect to MPPC:

(j) the MPPC Pipelines and all equipment, tanks, tubing, pumps, motors, compression equipment, flow lines, processing and separation facilities, materials and other real, personal and mixed property, operational and nonoperational, known or unknown, located in, on or connected to the MPPC Pipelines or other Assets and primarily used or held for use in connection with the MPPC Pipelines or other Assets;

(k) all Rights-of-Way that are used primarily in connection with the ownership or operation of any of the MPPC Pipelines or other Assets, including the Rights-of-Way set forth in Exhibit B;

(l) to the extent that they may be assigned without the payment of any fee or obligation on the Assignor, all Permits that are primarily used in connection with the ownership or operation of the MPPC Pipelines or other Assets;

(m) subject to Section 3.2(b) of the PSA, all line fill in the MPPC Pipelines or other Assets as of the Effective Time; and

(n) to the extent they may be assigned without the payment of any fee or obligation on the Assignor, the Existing Contracts.

With respect to EMPCo:

(o) Seller's (or its Affiliates) leasing contracts for the leased vehicles set forth on Schedule 2.2(a), to the extent such contract(s) may be assigned.

EXCEPTING AND RESERVING to Assignor, however, the Excluded Assets, as defined below.

TO HAVE AND TO HOLD the Assets unto Assignee, its successors and assigns, forever, in accordance with, and subject, however, to the terms and conditions of this Assignment and the PSA.

Section 2. Excluded Assets. "Excluded Assets" shall mean:

(a) all of Assignor's corporate minute books, financial records and other business records that relate to Assignor's business generally (including the ownership and

operation of the Assets) any of Assignor's or its Affiliates privileged or proprietary books, records or other items;

(b) all accounts, trade credits, accounts receivable, and all other proceeds, income or revenues attributable to the Assets with respect to any period of time prior to the Effective Time;

(c) all claims and causes of action, manufacturer's and contractor's warranties and other rights of Assignors arising under or with respect to any Existing Contracts that are attributable to periods of time prior to the Effective Time (including claims for adjustments or refunds), except to the extent any of the foregoing relates to any of the Assumed Obligations, and expressly including any claims of underpayment attributable those accounts set forth on Schedule 2.3(c) of the PSA;

(d) all rights and interests of Assignors (i) under any policy or agreement of insurance or (ii) with respect to all periods prior to the Effective Time, to any condemnation proceeds or awards arising;

(e) all proceeds from Hydrocarbons sold from the Assets with respect to all periods prior to the Effective Time;

(f) any claim, right or interest of Assignors in or to any refunds or loss carry forwards, together with any interest due thereon or penalty rebate arising therefrom, with respect to (i) any and all Taxes based on net income imposed on Assignors or any of its Affiliates, (ii) any Property Taxes allocable to Assignor pursuant to Section 13.1 of the PSA or (iii) any Property Taxes attributable to the Excluded Assets;

(g) all documents and instruments of Assignors that may be protected by an attorney-client or other privilege;

(h) all data that cannot be disclosed to Assignee as a result of confidentiality arrangements under agreements with third parties (provided that Assignor has used its commercially reasonable efforts to cause such confidentiality restrictions to be waived);

(i) all audit rights arising under any of the Existing Contracts or otherwise with respect to any period prior to the Effective Time, except to the extent relating to any of the Assumed Obligations, or to any of the Excluded Assets;

(j) all technical data and information relating to the Assets that cannot be transferred due to restrictions with third parties without payment of a fee or other penalty (unless Assignee agrees to, and does, pay such fees and penalties;

(k) concurrent rights to use all Rights-of-Way but only to the extent Assignor or any of its Affiliates currently uses such Rights-of-Way in connection with its use, ownership or operation of assets other than the Assets;

(l) any and all escrow accounts or bonds filed with or delivered or payable to any governmental authority or other third party by or on behalf of Assignor or any of its Affiliates

and any letters of credit, certificates of deposit, guarantees or similar security instruments on behalf of Assignor or any of its Affiliates set forth on Schedule 2.3(l) of the PSA;

(m) any master service agreements, blanket agreements or similar contracts and any ExxonMobil inter-Affiliate service agreements;

(n) overhead paid or payable by third parties to Assignor or its Affiliates in connection with the operation of the Assets and related properties prior to the Effective Time;

(o) Assignor and its Affiliates' intellectual property, including but not limited to, PLC programs;

(p) any services, systems, or software that are fully integrated into Assignor's existing systems, including proprietary and Third Party licensed software, and Assignor's SCADA hardware and software (segregation of the existing Assignor SCADA control will occur at the field PLC equipment and Assignee shall provide its separate and independent communication link to its controlling location);

(q) Assignors' (or their Affiliates) (i) computers and (ii) any leased vehicles not set forth on Schedule 2.2(a);

(r) employee records (other than records related to Employees who commence employment with Assignee that are required to be transferred pursuant to applicable Law, if any); and

(s) all Assignor Benefit Plans and the assets and liabilities thereof.

Section 3. Special Warranty. Subject to the terms and conditions of the PSA, Assignor warrants and agrees to defend Defensible Title to the Scheduled Properties by, through or under Assignor, but not otherwise, subject, however, to the Permitted Encumbrances. "Scheduled Property" means an Asset (as to the specified if provided, or, if not specified, the producing or producible formation, sand or unit) or other property interest specifically identified on Exhibit A or Exhibit B, if applicable. Assignee shall not be entitled to protection under Assignor's special warranty of Defensible Title to the Scheduled Properties with respect to (i) any matter of which Assignee or any of its Affiliates had Knowledge prior to the Defect Notice Date, or (ii) any matter reported to Assignor after the two-year anniversary of the Closing Date. Assignee shall be deemed to have waived all breaches of Assignor's special warranty of Defensible Title set forth in this Section 3 for which Assignee has not furnished to Assignor a valid Title Defect Notice that satisfies the requirements set forth in Section 4.3 of the PSA.

Section 4. No Other Warranty. Except as set forth in Section 4.2 of the PSA or Section 3 of this Assignment, the Assets are being assigned by Assignor to Assignee without warranty of title of any kind, whether common law or statutory, express or implied. To the extent transferable, Assignor hereby assigns to Assignee, its successors and assigns, full power and right of substitution and subrogation in and to all covenants and warranties (including warranties of title) by owners in Assignor's chain of title, vendors, or others, given or made with respect to the Assets or any part thereof prior to the Effective Time, excluding covenants and/or warranties given or made by any Affiliate of Assignor.

Section 5. Disclaimer of other Warranties.

(a) Except as and to the extent expressly set forth in Article IV of the PSA or in Section 3 of this Assignment, (i) Assignor makes no representations or warranties, express or implied, statutory or otherwise, with respect to title to any of the Assets, and (ii) Assignor expressly disclaims all liability and responsibility for any representation, warranty, statement, or information made or communicated (orally or in writing) to Assignee or any of its Affiliates, employees, agents, consultants, or representatives (including any opinion, information, projection, or advice that may have been provided to Assignee by any officer, director, employee, agent, consultant, representative, or advisor of Assignor or any of its or their Affiliates), with respect to the Assets.

(b) EXCEPT AS EXPRESSLY REPRESENTED OTHERWISE IN ARTICLE IV OF THE PSA OR IN SECTION 3 OF THIS ASSIGNMENT, ASSIGNOR MAKES NO, AND HEREBY EXPRESSLY DISCLAIMS AND NEGATES, ANY REPRESENTATION OR WARRANTY, EXPRESS, IMPLIED, OR STATUTORY AS TO (I) TITLE TO ANY OF THE ASSETS, (II) THE CONTENTS, CHARACTER, OR NATURE OF ANY REPORT OF ANY PETROLEUM ENGINEERING CONSULTANT OF ASSIGNOR, OR ANY ENGINEERING, GEOLOGICAL OR SEISMIC DATA OR INTERPRETATION, RELATING TO THE ASSETS, (III) THE QUANTITY, QUALITY, OR RECOVERABILITY OF HYDROCARBONS IN OR FROM THE ASSETS, (IV) ANY ESTIMATES OF THE VALUE OF THE ASSETS OR FUTURE REVENUES GENERATED BY THE ASSETS, (V) THE ABILITY TO PRODUCE HYDROCARBONS FROM THE ASSETS, (VI) THE MAINTENANCE, REPAIR, CONDITION, QUALITY, SUITABILITY, DESIGN OR MARKETABILITY OF THE ASSETS, (VII) THE CONTENT, CHARACTER OR NATURE OF ANY INFORMATION MEMORANDUM, REPORTS, BROCHURES, CHARTS OR STATEMENTS PREPARED BY ASSIGNOR OR THIRD PARTIES WITH RESPECT TO THE ASSETS, (VIII) ANY OTHER MATERIALS OR INFORMATION THAT MAY HAVE BEEN MADE AVAILABLE TO ASSIGNEE OR ITS AFFILIATES, OR ITS OR THEIR EMPLOYEES, AGENTS, CONSULTANTS, REPRESENTATIVES, OR ADVISORS IN CONNECTION WITH THE TRANSACTIONS CONTEMPLATED BY THE PSA OR ANY DISCUSSION OR PRESENTATION RELATING THERETO AND (IX) ANY IMPLIED OR EXPRESS WARRANTY OF FREEDOM FROM PATENT OR TRADEMARK INFRINGEMENT, AND, WITHOUT LIMITING ANY EXPRESS REPRESENTATION IN ARTICLE IV OF THE PSA, OR IN SECTION 3 OF THIS ASSIGNMENT, ASSIGNOR FURTHER DISCLAIMS ANY REPRESENTATION OR WARRANTY, EXPRESS, IMPLIED, OR STATUTORY, OF MERCHANTABILITY, FREEDOM FROM LATENT VICES OR DEFECTS, FITNESS FOR A PARTICULAR PURPOSE, OR CONFORMITY TO MODELS OR SAMPLES OF MATERIALS OF ANY OF THE ASSETS, RIGHTS OF AN ASSIGNEE UNDER APPROPRIATE STATUTES TO CLAIM DIMINUTION OF CONSIDERATION OR RETURN OF THE PURCHASE PRICE, OR RIGHTS OF AN ASSIGNEE UNDER DECEPTIVE TRADE PRACTICE STATUTES, CONSUMER PROTECTION STATUTES OR OTHER SIMILAR STATUTES, IT BEING EXPRESSLY UNDERSTOOD AND AGREED BY THE PARTIES THAT ASSIGNEE SHALL BE DEEMED TO BE OBTAINING THE ASSETS IN THEIR PRESENT STATUS, CONDITION AND STATE OF REPAIR, "AS IS, WHERE IS," WITH ALL FAULTS AND DEFECTS (KNOWN OR UNKNOWN, LATENT, DISCOVERABLE OR UNDISCOVERABLE), AND THAT ASSIGNEE HAS MADE OR CAUSED TO BE MADE SUCH INSPECTIONS AS ASSIGNEE DEEMS APPROPRIATE TO ENTER INTO THIS

ASSIGNMENT. ASSIGNOR AND ASSIGNEE AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW TO BE EFFECTIVE, THE DISCLAIMERS OF CERTAIN REPRESENTATIONS AND WARRANTIES CONTAINED IN THIS SECTION ARE "CONSPICUOUS" DISCLAIMERS FOR PURPOSES OF ANY APPLICABLE LAW, RULE OR ORDER.

Section 6. Further Assurances. After Closing, Assignor and Assignee each agree to take such further actions and to execute, acknowledge, and deliver all such further documents as are reasonably requested by the other for carrying out the purposes of this Assignment or the PSA or of any document delivered pursuant to the PSA.

Section 7. Assignment Subject to PSA. This Assignment is expressly subject to the terms and conditions of the PSA, which terms are hereby incorporated into this Assignment by reference for all purposes. In the event of a conflict between the terms of this Assignment and the PSA, the terms of the PSA shall control for all purposes. By executing, delivering and accepting this Assignment, Assignor and Assignee do not intend to cause a merger of the terms of the PSA into this Assignment and, unless expressly provided otherwise, all covenants, indemnities and other terms and provisions set forth in the PSA shall remain in full force and effect on and after the date hereof.

Section 8. Successors and Assigns. This Assignment shall bind and inure to the benefit of the Parties and their respective successors and permitted assigns; provided, however, nothing in this Assignment shall assign or grant, or in any way operate to assign or grant, any right, title or interest in, to or under the PSA to any successor or assign of Assignee with respect to the Assets or any part thereof, it being expressly understood that rights, titles and interests under the PSA may only be obtained or assigned in strict accordance with the terms thereof.

Section 9. Captions. The captions in this Assignment are for convenience only and shall not be considered a part of or affect the construction or interpretation of any provision of this Assignment.

Section 10. Governing Law. THIS ASSIGNMENT AND THE LEGAL RELATIONS AMONG ASSIGNORS AND ASSIGNEE SHALL BE GOVERNED AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS, EXCEPT TO THE EXTENT THE REAL PROPERTY LAWS OF THE STATE IN WHICH THE ASSETS ARE LOCATED REQUIRE THE APPLICATION OF THE LAWS OF SUCH STATE TO THE MATTERS CONTEMPLATED HEREIN. EACH OF ASSIGNORS AND ASSIGNEE CONSENT TO THE EXERCISE OF JURISDICTION IN PERSONAM BY THE COURTS OF THE STATE OF TEXAS FOR ANY ACTION ARISING OUT OF THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY. ALL ACTIONS OR PROCEEDINGS WITH RESPECT TO, ARISING DIRECTLY OR INDIRECTLY IN CONNECTION WITH, OUT OF, RELATED TO OR FROM THIS ASSIGNMENT OR THE OTHER TRANSACTION DOCUMENTS SHALL BE EXCLUSIVELY LITIGATED IN COURTS HAVING SITES IN HOUSTON, HARRIS COUNTY, TEXAS.

Section 11. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original instrument, but all such counterparts together shall constitute but one agreement.

Section 12. Parties in Interest; No Third Party Beneficiaries. Nothing in this Assignment shall entitle any Person other than Assignee and Assignor to any claim, cause of action, remedy or right of any kind. Only a Party and its successors and assigns will have the right to enforce the provisions of this Assignment on its own behalf or on behalf of any such Persons (but shall not be obligated to do so).

Section 13. Severability. If any provision of this Assignment, or any application thereof, is held invalid, illegal, or unenforceable in any respect under any Law, Assignee and Assignor shall negotiate in good faith such to reform this Assignment to the extent necessary to conform, in each case consistent with the intention of the Parties as set forth in the PSA, to such Law, and, to the extent such provision cannot be so reformed, then such provision (or the invalid, illegal, or unenforceable application thereof) shall be deemed deleted from (or prohibited under) this Assignment, as the case may be, and the validity, legality, and enforceability of the remaining provisions contained herein (and any other application of such provision) shall not in any way be affected or impaired thereby.

Section 14. Subject to Reservations. Without limitation of the definition of Permitted Encumbrances as set forth in the PSA, this Assignment is made subject to any and all easements, restrictions, covenants, conditions and reservations, if any, applicable to the Assets or any part thereof, including the terms, conditions, covenants, limitations, and obligations reflected in the real estate records maintained by the county clerk of the county in which the applicable Assets are located.

Section 15. Assumption. Without limiting Assignee's rights to indemnity under Section 11.2 of the PSA or under the special warranty in Section 3 hereof, on the Closing Date, except with respect to the Retained Liabilities, Assignee shall assume and hereby agrees to fulfill, perform, pay, and discharge (or cause to be fulfilled, performed, paid, or discharged) all of the Assumed Obligations.

Section 16. No Joint and Several Obligations. In the event that there are multiple Assignors under this Assignment, the obligations of each Assignor are several, and not joint and several.

Section 17. No Multiple Conveyances. Assignor and Assignee acknowledge and agree that they may be required to execute separate deeds and assignments covering certain of the Assets conveyed hereby on forms approved by governmental authorities or other Persons to effect the conveyances of such Assets. Any such separate deed or assignment (a) shall evidence this Assignment and conveyance of the applicable Assets herein made and shall not constitute any additional conveyance of any of the Assets, (b) is not intended to modify, and shall not modify, any of the terms, covenants and conditions or limitations on warranties set forth in this Assignment or the PSA and is not intended to create, and shall not create, any additional representations, warranties or covenants of or by Assignor or Assignee, and (c) shall be deemed to contain all of the terms and

provisions of this Assignment, as fully and to all intents and purposes as though the same were set forth at length in such separate deed or assignment.

Section 18. Filing. Assignee is responsible for, and Assignor hereby consents to, the recording, filing or other provision of this Assignment at Assignee's cost and expense in the public records of the applicable county(ies) and as otherwise necessary to provide notice of the transfer of ownership of the Assets from Assignor to Assignee.

San Ardo Terminal & Pipeline System

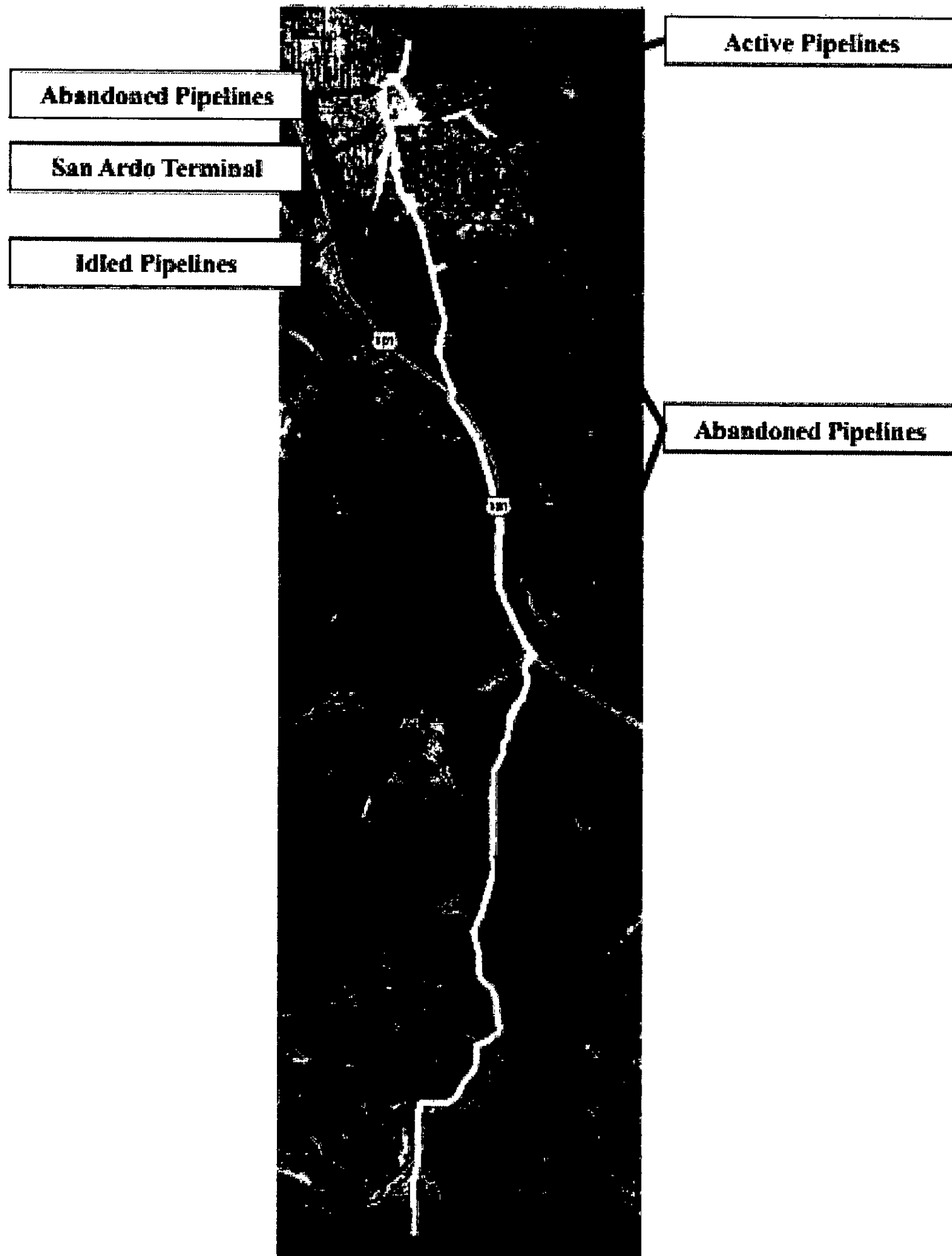


Exhibit A-1(b)

San Ardo Terminal & Pipeline System (enlarged)

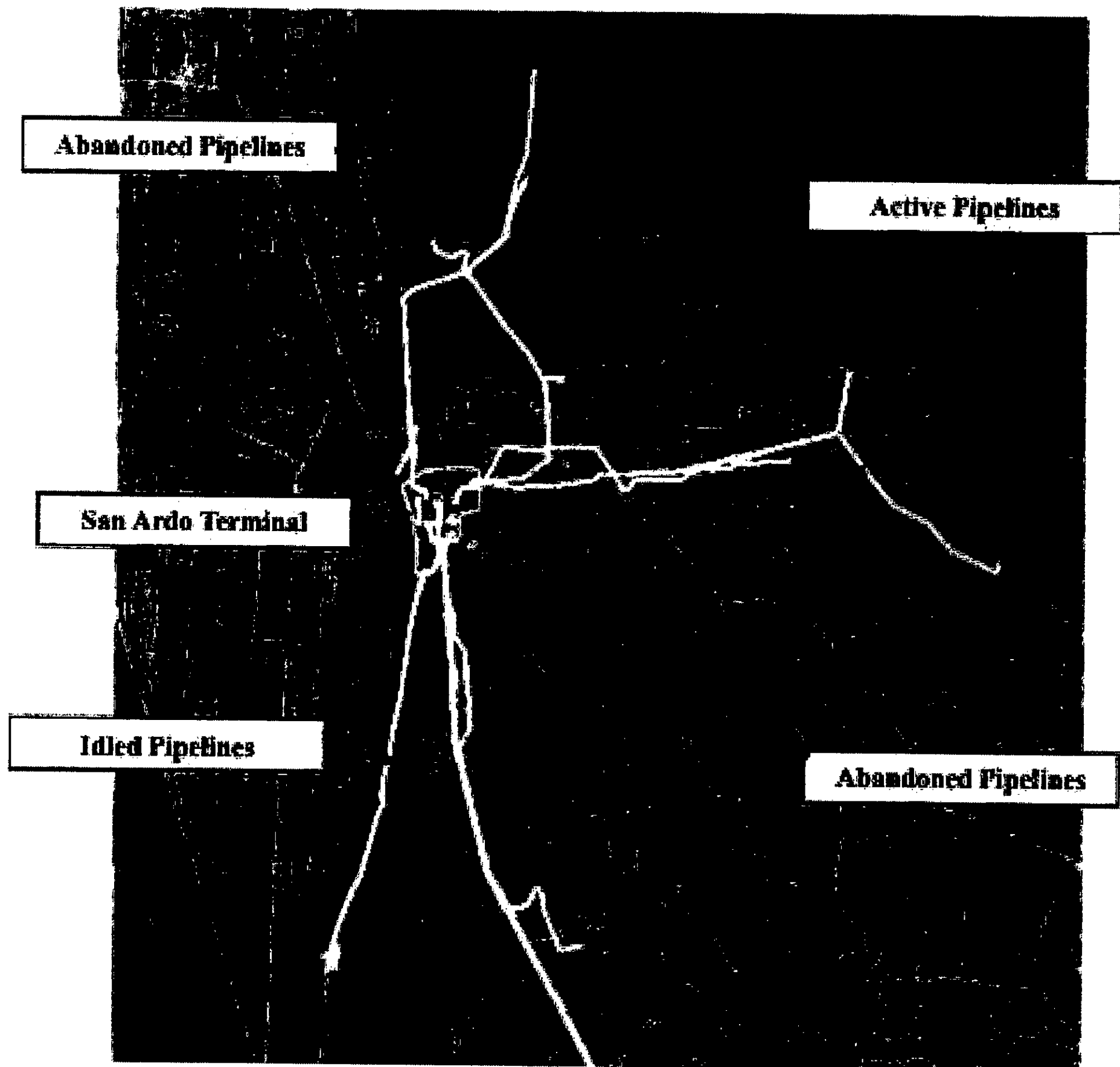

San Ardo Terminal

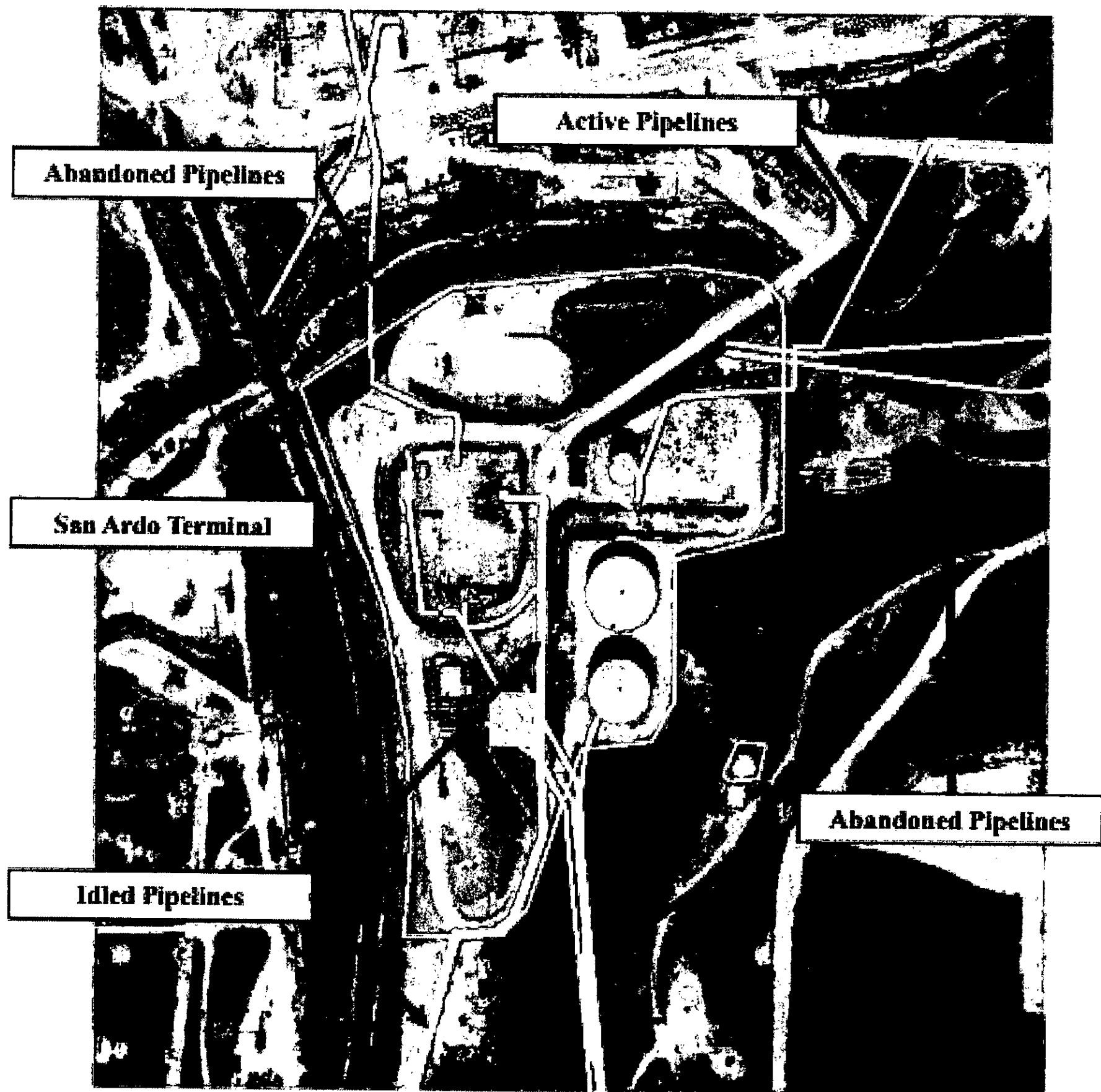


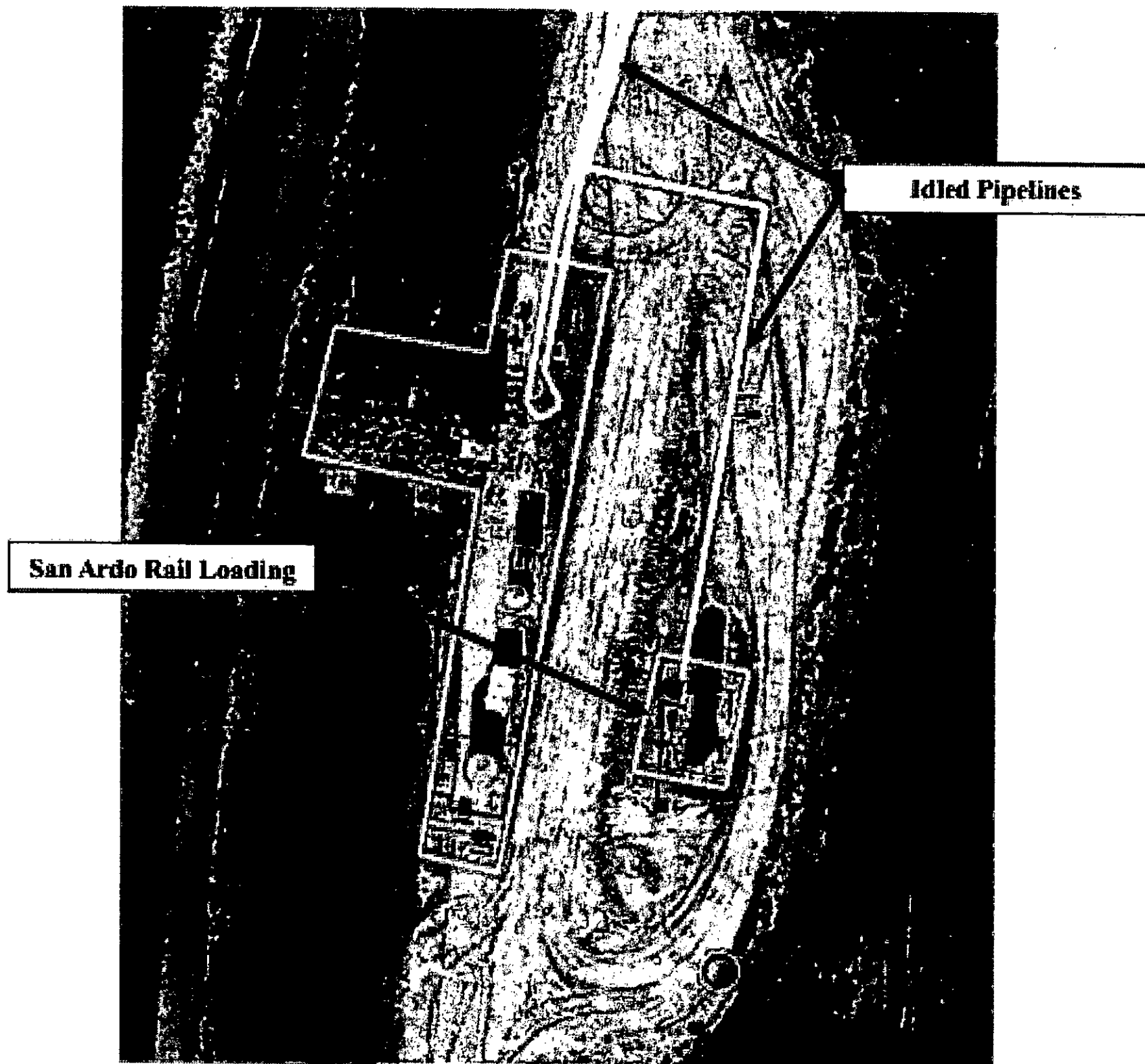

San Ardo Rail Loading



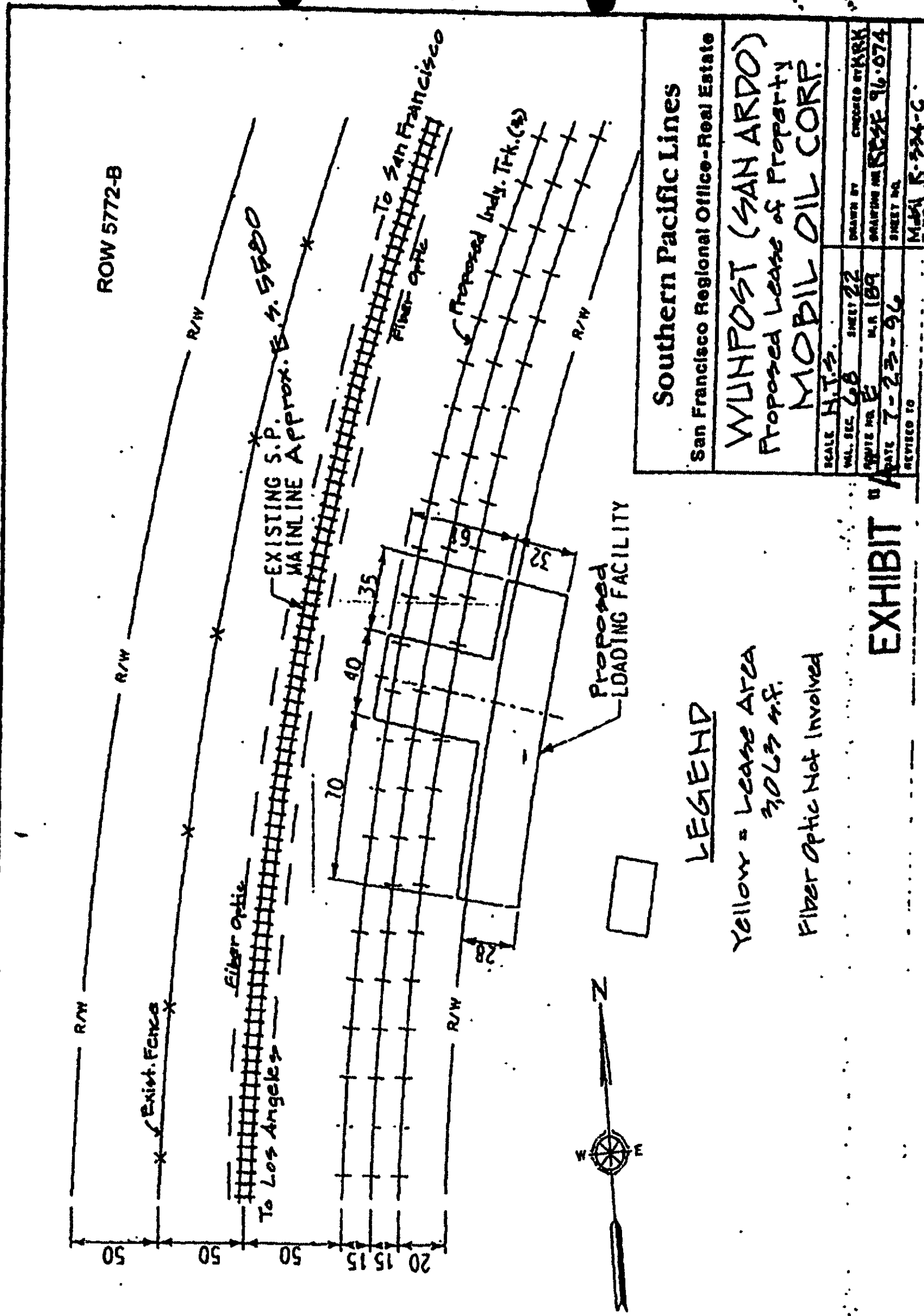
