Adopt a Resolution certifying compliance with state law with)
respect to the levying of general and special taxes, assessments,)
and property-related fees and charges.)

WHEREAS, on May 21, 2024, the Board of Supervisors of the County of Monterey, acting as the Board of Directors of the Boronda County Sanitation District, adopted Ordinance No. 5134 to provide for the collection of sewer charges through the County of Monterey (County) Property Tax Roll for the BCSD beginning with FY 2024-25;

WHEREAS, this Resolution has been prepared, consistent with said BCSD Ordinance No. 5416 to provide for the collection of annual sewer service charges on the Property Tax Roll in compliance with State and County requirements;

WHEREAS, this Resolution contains a report of sewer service charges for the property owners of record by jurisdictional boundaries of the BCSD which is attached and hereby incorporated by reference as Exhibit 1;

WHEREAS, Auditor-Controller's office enters those general and special taxes, assessments, or property related fees or charges identified in Exhibit 1 on the Property Tax Roll for collection and distribution by the Monterey County Treasurer-Tax Collector commencing with the property tax bills for Fiscal Year 2026-27;

NOW, THEREFORE, the Board of Supervisors of the County of Monterey acting as the Board of Directors of the BCSD hereby resolves and certifies that;

- a. BCSD hereby certifies that it has, without limitation, complied with all legal procedures and requirements necessary for the levying and imposition of the general or special taxes, assessments, or property-related fees or charges identified in Exhibit 1, regardless of whether those procedures and requirements are set forth in the Constitution of the State of California, in State statutes, or in the applicable decisional law of the State of California; and
- b. BCSD shall be solely liable and responsible for defending, at its sole expense, cost, and risk, each and every action, suit, or other proceeding brought against the BCSD, its officers, employees, and agents for every claim, demand, or challenge to the levying or imposition of the general or special taxes, assessments, or property-related fees or charges identified in Exhibit 1 and that it shall pay or satisfy any judgment rendered against the BCSD, its officers, employees, and agents on every such action, suit, or other proceeding, including all claims for refunds and interest thereon, legal fees and court

costs and administrative expenses of the County of Monterey to correct the Property Tax Roll.
