## AMENDMENT No. 2 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY and Steris Corporation

**THIS AMENDMENT No. 2** is made to the AGREEMENT, No. A-15384 by and between **Steris Corporation**, hereinafter "CONTRACTOR," and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County."

WHEREAS, on June 30, 2021, the County and CONTRACTOR entered into AGREEMENT in the amount of \$51,515.28 for the term of January 1, 2021, through December 31, 2023, for the provision of laboratory equipment inspection and maintenance services; and

WHEREAS, on January 12, 2024, the County and CONTRACTOR entered into Amendment No. 1 to extend the term for one additional year through June 30, 2024, and increase funds by \$6,595.12 for a new AGREEMENT amount not to exceed \$58,110.40; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to increase the amount by \$27,084.76 and extend the term to June 30, 2025, as specified below.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT as follows:

1. **Section 2.0 "PAYMENTS BY THE COUNTY"** is hereby amended and restated to read as follows:

"The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$58,110.40." and replacing it with "The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed \$85,195.16."

- 2. **Section 3.0 "TERM OF AGREEMENT"** is hereby amended and restated to read as follows:
- 3. "The term of this AGREEMENT is from January 1, 2021, to June 30, 2025, unless sooner terminated pursuant to the terms of this AGREEMENT. This AGREEMENT is of no force or effect until signed by both CONTRACTOR and County with County signing last, and CONTRACTOR may not commence work before County signs this AGREEMENT."
- 4. **EXHIBIT A-1** Scope of Services shall be amended for the extension of laboratory equipment inspection and maintenance services. Exhibit A-1 is deleted and replaced in its entirety and attached hereto as EXHIBIT A-2. All references in the AGREEMENT to EXHIBIT A-1 shall be construed to refer to EXHIBIT A-2.
- 5. Except as provided herein, all remaining terms, conditions, and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.

6. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on June 30, 2021.
