**WHEREAS, Darlene Hunter** provided leadership, innovation, and motivation to the Job Search Workshop program and its participants; and

**WHEREAS, Darlene Hunter** was the first to offer her time, experience, and support to peers, subordinates, and customers who sought her guidance and counsel and were inspired by her stories of lived experience and perseverance.
