

**Before the Board of Supervisors in and for the

Resolution No.:

Adopt a resolution commending ***Robert D. Vanderslice II***, Information Technology Department, upon his retirement from 33 years of public service.

WHEREAS, ***Robert D. Vanderslice II*** began his career in the public sector working in the field of information technology at the United States Navy in 1977 for six years and then joined the Fleet Numerical Oceanography Center; and

WHEREAS, ***Robert D. Vanderslice II*** joined the County of Monterey as a Programmer Analyst for the Information Technology Department (ITD) effective December 16, 1991; and

WHEREAS, ***Robert D. Vanderslice II*** was reclassified from Programmer Analyst to Systems Programmer Analyst II effective April 19, 2003; and

WHEREAS, ***Robert D. Vanderslice II*** was then promoted to Systems Programmer Analyst III effective July 10, 2004; and

WHEREAS, ***Robert D. Vanderslice II*** was then promoted to IT Supervisor effective October 5, 2013; and

WHEREAS, ***Robert D. Vanderslice II*** was reclassified from IT Supervisor to Information Technology Architect effective January 15, 2022; and

WHEREAS, ***Robert D. Vanderslice II***'s dedication to the County of Monterey's information technology services is legendary. Throughout his career, he has designed many of the systems that form the backbone of the ITD Data Center. In 2000, he introduced Microsoft Active Directory to ITD, establishing the County's information authorization and authentication system to secure critical data while enhancing user accessibility. In 2013, he led the County-wide email migration from an on-premises Microsoft Exchange system to a Cloud-based Microsoft Office 365 system, initiating the County's first Cloud-based Active Directory; and

WHEREAS, ***Robert D. Vanderslice II*** also introduced the IBM Tivoli enterprise backup and recovery solution in 2010, and in 2017 implemented a Commvault enterprise data backup system with a Cloud-based auxiliary copy, enhancing the County's disaster recovery capabilities if the on-site backup becomes unavailable. In 2018, he contributed to the establishment of the ITD Enterprise Architect Workgroup and delivered numerous innovative technical presentations, identifying and addressing critical single points of failure in the County's technology infrastructure. He challenged his team to think beyond the status quo, exemplified by his initiation of the Next Generation Data Center Project through a comprehensive Cloud migration analysis.

Vanderslice II*** for his dedicated service to the County of Monterey and wishes him success, good health, and happiness in all future endeavors.
