Adopt a resolution recognizing **Daniel Presser** for his distinguished service to veterans of the County of Monterey.

WHEREAS, Daniel Presser was born in Texas and attended Tulane University in New Orleans and Michigan State for graduate school; and

WHEREAS, Daniel Presser is a Vietnam era veteran and enlisted in the United States Navy in 1969 until his separation in 1975 as a Navy journalist and broadcaster; and

WHEREAS, Daniel Presser served as Commander of American Legion Post 41 during the most challenging times; and

WHEREAS, Daniel Presser assisted with restoration fundraising for the Sloat Monument Sculpture which was built in honor of Navy Commander John Drake Sloat and is currently located on the Presidio of Monterey; and

WHEREAS, Daniel Presser regularly attended the Fort Ord Veterans Cemetery meetings to be an active voice in the vision and development of the future cemetery at Fort Ord; and

WHEREAS, Daniel Presser's extensive list of volunteer and community involvement includes, past president of the American Cetacean Society Monterey Bay Chapter, served on the board of Water Plus, assisted the University of California in finding infected laurel trees which carry the pathogen of sudden oak death disease, provided free community lectures on jungles and animals from around the world and helped a tiny village in Fiji to restore a coral reef; and

WHEREAS, Daniel Presser currently works as owner of Four Winds Travel in Carmel, California; and

WHEREAS, Daniel Presser continues to support fellow veterans as a member of the Monterey County Military and Veteran Affairs Advisory Commission, and has volunteered for numerous years as the MC for the Annual Veteran of the Year Awards Ceremony; and

WHEREAS, Daniel Presser is a former referee for high school and college level football games. He enjoys traveling around the world, photography, running and staying active; and

WHEREAS, In his spare time, Daniel Presser likes to enjoy reading books and helping veterans. He and his wife Dr. Stephanie Taylor have been married for 38 years.
