WHEREAS, on April 26, 1966, the Board of Supervisors adopted Resolution No. 66-185 to establish a Parks Commission and set the rules and regulations for the operations of said Commission;

WHEREAS, on July 29, 1980, the Board of Supervisors adopted Resolution No. 80-430 which reestablished the rules and regulations for the Parks Commission;

WHEREAS, on August 28, 1990, the Board of Supervisors adopted Resolution No. 90-497 amending Section 4 of Resolution 80-430 to set the term of office for Parks Commission members at four years;

WHEREAS, on April 24, 2018, the Board of Supervisors adopted Resolution 18-048 amending Section 2 of Resolution 90-047 to establish an ad hoc committee to work with Resource Management Agency during transition of the Parks Department; appoint District 5 Supervisor to Commission and clarify originating history, rules and regulations; rescind the rules and regulations established in Resolution 66-185 and 80-430.

WHEREAS, on June 8, 2021, the Board of Supervisors adopted Resolution 21-160 to revise the rules and regulations of the Monterey County Parks Commission;

WHEREAS, the Board of Supervisors wishes to increase the Parks Commission membership from six to seven members by adding an “at large” member.

WHEREAS, the Monterey County Parks Commission Bylaws will become effective immediately upon adoption by the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED, THAT the Monterey County Board of Supervisors hereby rescinds the rules and regulations established in Resolutions No. 66-185, No. 80-430, 18-048, and 21-160 and adopts the rules and regulations for the Monterey County Parks Commission, hereafter known as the *Monterey County Parks Commission Bylaws*, as set forth in Attachment A.
