### **RECOMMENDATION:**

It is recommended that the Board of Supervisors receive the Monterey County Fish and Game Advisory Commission 2024 Annual Report.

### **SUMMARY:**

The Monterey County Fish and Game Advisory Commission 2024 Annual Report is submitted to the Board of Supervisors.

### **DISCUSSION:**

The Monterey County Fish and Game Advisory Commission (Commission) was established by Board Order on June 20, 1947 to act in an advisory capacity to the County of Monterey Board of Supervisors (Board) on the expenditure of Fish and Game funds. County of Monterey Resolution No. 81-239 adopted by the Board on April 28, 1981 (Resolution), created the Monterey County Fish and Game Advisory Commission, and set the rules and regulations for the operation of the Commission.

The Commission is charged with submitting an annual report to the Board of Supervisors summarizing the Commission's activities for the prior year.

Staff requests the Board receive the Commission's 2024 Annual Report (Attachment A).

### **OTHER AGENCY INVOLVEMENT/COMMITTEE ACTIONS:**

The Department of Public Works, Facilities and Parks serves as staff to the Commission. The report was reviewed for accuracy by the Commission Chair. The Office of County Counsel has reviewed and approved the report.

### **FINANCING:**

Commissioners serve without compensation other than for reimbursement of reasonable and necessary expenses incurred for travel, lodging, and meals while on official business. Reimbursement is subject to the approval of the Director of Public Works, Facilities and Parks, the Department Head designated by the Board of Supervisors.

**BOARD OF SUPERVISORS STRATEGIC PLAN GOALS:**

The Commission's advisory role to the Board of Supervisors serves to promote, protect, and preserve the area's fish and wildlife resources and local environment. Resolution 81-239 adopted on April 28, 1981 requires the Commission to submit an Annual Report to the Board of Supervisors which promotes the goal of transparency in government.
