Adopt a resolution proclaiming the week of April 14-18, 2025 as **Environmental Health Week** in Monterey County, and recognizing the California Environmental Health Association gathering in Monterey County for its 73rd annual educational symposium.

WHEREAS, the California Environmental Health Association (CEHA) will be gathering in Monterey County for its 73rd Annual Educational Symposium from April 14 to 18, 2025, to provide education, resources, and discussions on critical environmental health issues that impact communities across the state of California; and

WHEREAS, the CEHA Symposium brings together experts, professionals, students, and local leaders to share knowledge, enhance environmental health practices, and build stronger communities through collaborative efforts to address the various challenges related to environmental health, including air and water quality, food safety, waste management, and hazardous materials management; and
