

**AMENDMENT NO. 1 TO AGREEMENT BETWEEN
MONTEREY COUNTY WORKFORCE DEVELOPMENT BOARD AND
BRENNAN WORKFORCE CONSULTING FOR WIOA PROGRAM AND FISCAL
MONITORING SERVICES**

This Amendment No. 1 is made to the Professional Services Agreement for the provision of WIOA Program and Fiscal Monitoring services, by and between Brennan Workforce Consulting, hereinafter "Contractor," and the Monterey County Workforce Development Board, hereinafter "MCWDB," both of which are collectively referred to as "the parties."

WHEREAS, effective July 1, 2022, the MCWDB and Contractor entered into an Agreement in the amount of \$45,000 to provide WIOA subrecipient program and fiscal compliance monitoring to include Equal Opportunity compliance monitoring ("the Agreement"); and

WHEREAS, the MCWDB and Contractor wish to amend the Agreement, pursuant to this Amendment No. 1, to increase the amount of the Agreement by \$25,000, for a total aggregate amount not to exceed \$70,000 for the total aggregate term of July 1, 2022 through June 30, 2024; and extend the term of the Agreement for one (1) additional year.

NOW THEREFORE, the MCWDB and CONTRACTOR hereby agree to amend the Agreement, pursuant to this Amendment No. 1, in the following manner:

1. Section IV (A) shall be amended by removing the language, "This Agreement shall be effective retroactive to July 1, 2022 and remain in full force and effective through June 30, 2023," and replacing it with **"This Agreement shall be effective retroactive to July 1, 2022 and remain in full force and effective through June 30, 2024."**
2. Section IV (C) (1) shall be amended by removing the language, "Funding available for the project term of July 1, 2022 to June 30, 2023 is \$45,000," and replacing it with **"Funding available for the project term of July 1, 2022 to June 30, 2024 is \$70,000."**
3. Exhibit B, "Budget Summary," shall be amended by replacing it with Exhibit B-1, "Amended Budget Summary, WIOA Title 1 Program and Fiscal Compliance Monitoring Services, July 1, 2022 through June 30, 2024," attached to this Amendment No. 1.

Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.

A copy of this Amendment No. 1, including attachments, shall be attached to the original Agreement dated July 1, 2022.
