

AMENDMENT #2 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & Plexus Global LLC.

THIS AMENDMENT is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of DOT Drug and Alcohol Program TPA Services by and between **Plexus Global LLC**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY”.

WHEREAS, the COUNTY and CONTRACTOR previously entered into the original AGREEMENT on January 30, 2020, in the amount not to exceed \$50,000.00 with a term from January 27, 2020 through January 26, 2023; and

WHEREAS, the COUNTY and CONTRACTOR amended the AGREEMENT by way of Amendment #1 extending the term by one (1) additional year through January 26, 2024; and

WHEREAS, the COUNTY and CONTRACTOR wish to amend the AGREEMENT to add updated pricing per **Exhibit A1** and to extend the term by one (1) additional year through **January 26, 2025**; and

NOW THEREFORE, the COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **Section 3, “TERM OF AGREEMENT”, shall be amended by removing “The term of this Agreement is from January 27, 2020, to January 26, 2023, unless sooner terminated pursuant to the terms of this Agreement”, and replacing it with “The term of this Agreement is from January 27, 2020, to January 26, 2025, unless sooner terminated pursuant to the terms of this Agreement”.**
2. **Section 4, “SCOPE OF SERVICES AND ADDITIONAL PROVISIONS” – EXHIBIT A - Scope of Services/Payment Provisions** shall be amended by updating pricing as per **EXHIBIT A1** per Amendment #2 attached hereto.
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated January 27, 2020.



- Provide all Supervisors / Managers directly the passports / cover letters and / or a specific Federal Transit Authority (FTA) passport
- Report results directly back to the Supervisors / Managers and work directly the Supervisors / Managers regarding their respective employees going to take their drug and / or alcohol screen
- Send all completed reports to the DER and other requested staff
- Manage all necessary driver screening documentation and make sure it is all uploaded at the driver report level for the DER to have access
