Please tell us about yourself and why you want serve:

I am a 1979 graduate of the United States Merchant Marine Academy with honors, part of the first class of women admitted to any federal academy through the regular admissions process. I then served as a deck officer on a wide variety of

merchant vessels including 15 years for AT&T installing and maintaining submarine telephone cable as well as supervising construction and commissioning of three new ships. I retired from the American Maritime Officers union as Captain in 1999. I was then appointed to the Planning Commission in 2001, where I have served since through the development and adoption of the 2010 General Plan. In 2003 I enrolled as part of the initial class in the CSUMB/Panetta Institute Masters of Public Policy program and graduated from that in 2006. I have lived in Big Sur at my current residence, located 7 miles south of the house my great grandparents built, since 1986. I am actively involved with my community. I care about this County and in particular Big Sur and the highway south of Carmel. I have served on the Monterey County Planning Commission since 2001 and BSBO since 2019.

I have been involved with the development and subsequent implementation of the Big Sur Coast Highway Management Plan as a community member since 2002. The Big Sur Byways Organization was created to help implement that plan. I have served on BSBO as chair since it was established.
