**AMENDMENT NO. 3
TO SERVICES AGREEMENT
BETWEEN META DYNAMIC, INC. AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
RENTAL OF GUIDED SURGERY EQUIPMENT AND SERVICES.**

This Amendment No. 3 to the Services Agreement ("Agreement") which was effective on April 15, 2024 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and META Dynamic, Inc. ("CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed for Rental of Guided Surgery Equipment and Services with a term April 15, 2024 through April 14, 2026 and a total Agreement amount not to exceed \$200,000; and

WHEREAS, the Parties amended the Agreement on June 6, 2025 via Amendment No. 1 with no changes to the Agreement term and no changes to the original scope of work with a \$100,000 increase for a revised total Agreement amount not to exceed \$300,000; and

WHEREAS, the Parties amended the Agreement via Amendment No. 2 to extend the term for an additional one (1) year period through April 14, 2027 for a revised full Agreement term of April 15, 2024 through April 14, 2027 with no changes to the original scope of work and with a \$200,000 increase for a revised total Agreement amount not to exceed \$500,000; and

WHEREAS, the Parties currently wish to amend the Agreement to increase the payable amount by \$200,000 for a revised total Agreement amount not to exceed \$700,000, with no change to the scope of work and no change to the Agreement term of April 15, 2024 through April 14, 2027.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No. 1, Amendment No. 2, and Amendment No. 3 incorporated herein by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, "PAYMENTS BY COUNTY" shall be amended to the following:
"The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$700,000."
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement, Amendment No. 1, and Amendment No. 2.
3. A copy of this Amendment No. 3 shall be attached to the Agreement.
4. This Amendment No. 3 shall be effective when signed by the Parties.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Amendment No. 3 on the basis set forth in this document and have executed this Amendment No. 3 on the day and year set forth herein.
