

**AMENDMENT NO. 2
TO SERVICES AGREEMENT
BETWEEN CLINICAL COMPUTER SYSTEMS, INC. AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
SUPPORT SERVICES FOR THE OBIX PERINATAL DATA SYSTEM**

This Amendment No. 2 to the Services Agreement (“Agreement”) which was effective on April 1, 2016 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (“NMC”), and Clinical Computer Systems, Inc. (“CONTRACTOR”); **From this point forward, the party referenced previously as “NMC” shall be referenced as “COUNTY” and collectively, COUNTY and CONTRACTOR are referred to as the “Parties” to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed for OBIX Perinatal Data Systems support services with a term of April 1, 2016 through March 31, 2021 and a total Agreement amount not to exceed \$130,394; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on March 15, 2021 via Amendment No. 1 to extend the term for an additional five (5) year period through March 31, 2026 with additions to the original scope of work and to add an additional \$266,450 for a total Agreement amount not to exceed \$396,844; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period through March 31, 2027 for a revised full Agreement term of April 1, 2016 through March 31, 2027 to allow for services to continue with revisions to the original scope of work attached hereto as “Exhibit A-2 per Amendment No. 2” with a \$51,449 increase for a revised total Agreement amount not to exceed \$448,293.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No 1, and in Amendment No. 2 incorporated by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, “PAYMENTS BY COUNTY” shall be amended to the following:
“COUNTY shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A plus EXHIBIT A-2 as per Amendment No. 2 attached hereto this Amendment No. 2. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$448,293
2. The first sentence of Section 3 /Paragraph titled, “TERM OF AGREEMENT” shall be amended to the following:
“The term of this Agreement is from April 1, 2016 through March 31, 2027 unless sooner terminated pursuant to the terms of this Agreement.”
3. Section 4/ Paragraph titled, “SCOPE OF SERVICES AND ADDITIONAL PROVISIONS/EXHIBITS” shall be amended to the following:
***“The following attached exhibits are incorporated herein by reference and constitute a part of this Agreement:
Exhibit A: Scope of Services/Payment Provisions

4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and in Amendment No. 1.
5. A copy of this Amendment No. 2 shall be attached to the Agreement.
6. This Amendment No. 2 shall be effective when signed by both Parties.
