**WHEREAS, Interim, Inc.** was founded in 1975, and began as a small grassroots organization with a vision to fill the critical gaps in mental health services for adults who did not qualify for traditional systems of care, and has since grown into Monterey County's leading provider of affordable housing and behavioral health support; and

**WHEREAS,** on the occasion of its **50th Anniversary, Interim, Inc.** stands as a model of innovation, resilience, and advocacy—proving that recovery-oriented, affordable housing and mental health services transform lives and strengthen communities; and

**WHEREAS,** for five decades, **Interim, Inc.** has embodied the principle that mental health recovery is possible when people are empowered with stability, dignity, and community—offering an array of innovative programs that integrate housing, treatment, peer support, and independent living skills; and

**WHEREAS, Interim, Inc.** operates more than 20 residential and service sites across Monterey County, including MCHOME, Manzanita House, Sunflower Gardens, and Rockrose Gardens, providing safe, affordable homes and supportive services to hundreds of individuals each year; and

**WHEREAS,** through partnerships with Monterey County Behavioral Health, the City of Salinas, the City of Seaside, and other regional agencies, **Interim, Inc.** continues to expand access to care and improve outcomes for vulnerable populations—serving as a cornerstone of Monterey County's housing and health safety net; and

**WHEREAS, Interim, Inc.** is widely recognized for its trauma-informed, client-centered approach that not only addresses immediate needs but also fosters long-term recovery, stability, and hope for individuals and families impacted by mental illness; and

**WHEREAS, Interim, Inc.** continued success reflects the dedication and vision of its leadership, staff, volunteers, and community partners who have upheld Interim's mission for five decades with compassion and integrity; and
