Adopt a resolution commending **Jon D. Anthony** upon his retirement after 25 years of dedicated public service with the County of Monterey

**WHEREAS**, the County of Monterey has been well served by dedicated public servants whose commitment and integrity strengthen the safety, fairness, and well-being of the community; and

**WHEREAS**, County Park Rangers serve an important function of enforcing local, State and Federal regulations, keeping the public safe, responding to life-threatening emergencies, managing wildlife and providing customer service; and

**WHEREAS**, County Park Rangers encounter endless situations while patrolling and providing law enforcement services such as domestic disturbances, gang violence, drug and alcohol possession, wildlife poaching, traffic and boating accidents, wildfires, chemical spills, traumatic injuries, illegal firearm use, search and rescue operations and natural disasters; and

**WHEREAS**, **Jon D. Anthony** began his career with the Monterey County Resource Management Agency (RMA) Department in July 2002, when he was hired as a Road Maintenance Helper; and

**WHEREAS**, through his hard work, **Jon D. Anthony** was promoted to Road Maintenance Worker in June 2003; and

**WHEREAS**, in March 2006, **Jon D. Anthony** began his career as a County Park Ranger I, in a Peace Officer capacity patrolling the county parks system, providing law enforcement and emergency medical services; and

**WHEREAS**, through hard work and dedication, **Jon D. Anthony** was promoted to County Park Ranger II in March 2007; and

**WHEREAS**, In March 2008, **Jon D. Anthony** was promoted to County Park Ranger III, a role he fulfilled with a deep sense of responsibility and professionalism over the next five years; and

**WHEREAS**, through demonstrated leadership, and unwavering dedication, **Jon D. Anthony** was promoted to a County Park Ranger Supervisor in May 2013, a role he fulfilled for the next twelve years with commitment to public service; and

**WHEREAS**, **Jon D. Anthony**, while sacrificing family time, missing first steps and words, foregoing holiday celebrations and selflessly putting his own health and life on the line, running towards danger, not away from it, has responded to thousands of calls for service during his tenure at a County Park Ranger, saved countless lives, administered first aid and CPR to dozens of accident and drowning victims and has left County Parks a better place than when he arrived; and

**WHEREAS, Jon D. Anthony** enjoys helping the community, and has been a volunteer firefighter for the South Monterey Fire Protection District for 30 years and he looks forward to spending time with family and friends and enjoying holidays and vacations.

**NOW, THEREFORE BE IT RESOLVED**, that the County of Monterey Board of Supervisors, on behalf of the County, and all residents thereof, hereby acknowledges, commends, and thanks **Jon D. Anthony** for his twenty five years of exemplary public service, leadership, and unwavering commitment to the people of the County of Monterey and extends its sincere appreciation and best wishes to him on his well-deserved retirement.
