

**AMENDMENT No. 3
TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY AND
COMMUNITY FOUNDATION FOR MONTEREY COUNTY**

THIS AMENDMENT No. 3 is made to the COUNTY OF MONTEREY STANDARD AGREEMENT (“AGREEMENT”) for the provision of management and implementation of the Virus Integrated Distribution of Aid (VIDA) Project, formerly known as the Community Outreach and Education Pilot Project (“Pilot Project”), by and between **COMMUNITY FOUNDATION FOR MONTEREY COUNTY**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into the AGREEMENT in the amount of \$4,989,651 with a term of January 1, 2021 through June 30, 2021;

WHEREAS, the County and CONTRACTOR entered into an Amendment No. 1 to the AGREEMENT, to extend the term of the AGREEMENT to September 30, 2021;

WHEREAS, the County and CONTRACTOR entered into an Amendment No. 2 to the AGREEMENT to extend the term of the AGREEMENT to March 31, 2022;

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT due to County’s need for CONTRACTOR’s services; and

WHEREAS, County and CONTRACTOR wish to increase the maximum contract liability of AGREEMENT by \$ \$1,570,012 for an amount not to exceed \$6,559,663, extend the term through December 31, 2022 and replace section B.2 CONTRACTOR Deliverables and C.1.1 PAYMENT PROVISIONS in **Exhibit A, Purpose of Funding/Scope of Services/Payment Provisions**.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **Paragraph 3, “TERM OF AGREEMENT”, shall be amended by removing** “The term of this Agreement is from **January 1, 2021 to June 30, 2021**, unless sooner terminated pursuant to the terms of this Agreement”, **and replacing it with** “The term of this Agreement is from **January 1, 2021 to December 31, 2022**, unless sooner terminated pursuant to the terms of this Agreement”.
2. **Section 14.0 NOTICES shall be amended by removing** “Nicholas E. Chiulos, Assistant County Administrative Officer, 168 West Alisal Street, third Floor, Salinas, CA 93901” **and replacing with** “Krista Hanni, Program Manager, 1270 Natividad Road, Salinas, CA 93906.”
3. **Section B.2, “SCOPE OF SERVICES”** shall be replaced with following table of deliverables:

4. **Section C “PAYMENT PROVISIONS”** shall be amended by removing “The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$4,989,651 for the performance of all things necessary for or incidental to the performance of work as set forth in the Scope of Work. CONTRACTOR’s compensation for services rendered shall be based on the following rates or in accordance with the following terms: Upon submission of progress reports, submit invoices for the periods listed below as follows: January 1, 2021 – June 30, 2021 = \$4,989,651.” and replacing it with “the total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$6,559,663 for the performance of all things necessary for or incidental to the performance of work as set forth in the Scope of Work. CONTRACTOR’s compensation for services rendered shall be based on the following rates or in accordance with the following terms: Upon submission of progress reports, submit invoices for the periods listed below as follows: January 1, 2021 – December 31, 2022 = \$6,559,663”

5. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.

6. A copy of this AMENDMENT shall be attached to the original AGREEMENT effective January 1, 2021.


