

**RENEWAL AND AMENDMENT No. 3 TO AGREEMENT BY AND
BETWEEN
COUNTY OF MONTEREY & CITY OF SEASIDE POLICE
DEPARTMENT**

THIS RENEWAL AND AMENDMENT No. 3 to AGREEMENT is entered by and between **CITY OF SEASIDE POLICE DEPARTMENT** hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into that certain AGREEMENT for victim services with a term of July 1, 2016 through June 30, 2018 for a contract total amount of \$31,000.

WHEREAS, the County and CONTRACTOR entered into an AMENDMENT No. 1, dated May 2, 2018, to AGREEMENT, extending the AGREEMENT to December 31, 2019;

WHEREAS, the County and CONTRACTOR entered into a RENEWAL AND AMENDMENT No. 2, effective December 31, 2019, reinstating the AGREEMENT, adding four years, and adding \$56,072, for a revised total liability of \$87,072; and

WHEREAS, the AGREEMENT expired by its terms on December 31, 2023; and

WHEREAS, the County and CONTRACTOR have since continued to perform under the AGREEMENT and otherwise conduct themselves as if it remained in force; and

WHEREAS, the County and CONTRACTOR mutually desire to reinstate the AGREEMENT with effect date retroactive to December 31, 2023, and to amend the AGREEMENT as provided below; and,

WHEREAS, the California Governor’s Office of Emergency Services (Cal OES) has provided grant funding for this Agreement in the following amount for the following grant period: \$18,938 for CY 2024.

NOW THEREFORE, the County and CONTRACTOR hereby agree as follows:

1. The expiration of the AGREEMENT is hereby revoked and, except as expressly modified by this RENEWAL AND AMENDMENT #3, the AGREEMENT shall be, and hereby is, retroactively reinstated in its entirety and shall be, and shall be considered to have been at all relevant times as provided herein, in full force and effect as if the same had never expired.
2. **Paragraph 3, “TERM OF AGREEMENT”, shall be amended by removing “The term of this Agreement is from July 1, 2016 to December 31, 2023, unless sooner terminated pursuant to the terms of this Agreement” and replacing it with “The term of this Agreement is from July 1, 2016 to December 31, 2024, unless sooner terminated pursuant to the terms of this Agreement.”**

3. Effective as of January 1, 2024 through December 31, 2024, **Paragraph 2, “PAYMENT PROVISIONS”, is amended by removing** “The total amount payable by the County to CONTRACTOR under this agreement is not to exceed the sum of **\$87,072**” and replacing it with “The total amount payable by the County to CONTRACTOR under this agreement is not to exceed the sum of **\$106,010.**”
4. This RENEWAL AND AMENDMENT No. 2 is adopted as of March 26, 2024, but the effective date of the various provisions hereof shall be such retroactive dates as are otherwise specifically provided herein.
5. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this RENEWAL AND AMENDMENT No. 3 and shall continue in full force and effect as set forth in the AGREEMENT.
6. A copy of this RENEWAL AND AMENDMENT No.3 shall be attached to the original AGREEMENT, as amended.
