- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on September 1, 2023.

The employee count is increased from 3,300 to 5,000 with the addition of Natividad Medical Center employees, effective April 1, 2024. As a result:

1. The Annual Service Fees are increased from \$61,000 to \$73,750.

2. County will be invoiced the prorated amount of 6,375 (reflecting the annual renewal date on 10/1/2024) of 12,750 (amount of annual increase) based on the effective date of this amendment and months remaining in the term (6 months).

3. Payment will be due 30 days from the day County Auditor-Controller receives the certified invoice. Please refer to Section 6.0 PAYMENT CONDITIONS of the original AGREEMENT.
